

IV Bar Group – Privacy Policy for In-Store Cameras

1. Introduction

This Privacy Policy outlines how IV Bar Group ("we," "us," or "our") collects, uses, discloses, and protects personal information captured through surveillance cameras installed in and around our store premises. We are committed to respecting and protecting your privacy and complying with all applicable data protection laws.

2. Information We Collect

We may collect the following categories of personal information through our store cameras:

- a. Visual and Audio Data: Our surveillance cameras may capture images and audio recordings of individuals within the camera's field of view. This data may include but is not limited to facial images, clothing, and conversations.
- b. Date and Time Information: We record the date and time when surveillance footage is captured.
- c. Location Data: We collect information about where the cameras are placed and the areas they cover within our store premises.

3. Purpose of Data Collection

We collect and process personal information obtained through our store cameras for the following purposes:

- b. Rectification: You can request the correction of any inaccurate or incomplete personal information we have collected.
- c. Deletion: You have the right to request the deletion of your personal information unless we are required by law to retain it.

7. Security Measures

We take appropriate technical and organizational measures to protect the personal information captured through our store cameras from unauthorized access, disclosure, alteration, or destruction.
